IECMH Trainings

Reflective Supervision/Consultation (RSC) Updates

- Starting January 2024, we will no longer vet RSC providers, all RSC hours earned from January 1, 2024 and on must be from someone endorsed at a qualifying category
 - Masters-prepared Family Specialists & Mental Health Specialists <u>only until</u> <u>December 2024</u>
 - Endorsed Reflective Supervisor add-on & Mental Health Mentor Clinical preferred
- For initial Endorsement, you can use RSC hours earned through December 31, 2023 from someone who was vetted.
- Deadline for "qualifying" endorsed RSC providers extended until December 2024 meaning Masters-prepared Family Specialists and Mental Health Specialists will still be able to provide RSC for applicants/endorsees.
- Starting January 2025, only those with the ERS add-on or MHM-C can provide qualifying hours of RSC for Endorsement (see chart below)
